In the reference 4th read above, the Director of Mines and Geology submitted proposals for necessary amendments to the District Mineral Foundation (Trust) Rules, 2015 for establishment of the District Mineral Foundation (Trust) in the districts not having the District Mineral Foundation and transfer of amount paid towards District Mineral Foundation by the lease holders before 11.10.2016 from the existing District Mineral foundation account to the District Mineral Foundation being established, as per the location of leases with reference to the territorial jurisdiction of the new districts.

In exercise of the powers conferred by sub-section (4) of Section 15 of the Mines and Minerals (Development and Regulation) Act, 1957 (Central Act 67 of 1957) as amended by Act 10 of 2015 and guided by the provisions contained in Article 244 read with Fifth and Sixth Schedule to the Constitution relating to administration of the Scheduled Areas and Tribal Areas and the provisions of the Panchayats (Extension to the Scheduled Areas) Act, 1996, and the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006, the Governor of Telangana hereby makes the following amendments to the District Mineral Foundation (Trust) Rules, 2015 issued in G.O.Ms.No.3, Industries and Commerce (Mines.I) Department, dated 20.01.2016:-

AMENDMENTS

in the said rules,

Rule 2.3 shall be amended namely:-

In addition to the existing District Mineral Foundation in Mancherial, Nizamabad, Medak, Karimnagar, Warangal Urban, Nalgonda, Mahabubnagar, Rangareddy and

Khammam Districts, the District Mineral Foundation shall be established in the Districts of Adilabad, Kumerambheem Asifabad, Nirmal, Kamareddy, Sangareddy, Siddipet, Peddapalli, Jagityal, Rajanna Siricilla, Warangal Rural, Mahabubabad, Prof. Jayashankar Bhupalalpalli, Jangaon, Bhadradri at Kothagudem, Suryapet, Yadadri Bhongir, Nagarkurnool, Wanaparthy, Jogulamba Gadwal, Vikarabad and Medchal-Malkajgiri Districts. Every District Mineral Foundation will have a Governing Council and a Managing Committee.

In Rule 13, after 13.3, the following shall be inserted:

- There shall be transfer of amount paid towards District Mineral Foundation by the lease holders before 11.10.2016 from the existing District Mineral Foundation in Mancherial, Nizamabad, Medak, Karimnagar, Warangal Urban, Nalgonda, Mahabubnagar, Rangareddy and Khammam Districts to the District Mineral Foundation being established in Adilabad, Kumerambheem Asifabad, Nirmal, Kamareddy, Sangareddy, Siddipet, Peddapalli, Jagityal, Rajanna Siricilla, Warangal Rural, Mahabubabad, Prof. Jayashankar Bhupalapalli, Jangaon, Bhadradri at Kothagudem, Suryapet, Yadadri Bhongir,, Nagarkurnool, Wanaparthy, Jogulamba Gadwal, Vikarabad and Medchal-Malkajgiri Districts, as per the location of leases with reference to the territorial jurisdiction of the new districts.
- 6. Further the Government hereby nominate the Ministers to act as a Ex-Officio Chairperson to the Governing Council of each District Mineral Foundation as appended to this order.
- 7. The Director of Mines and Geology, Hyderabad shall take further necessary action.
