ORDER

1. In the G.O. read above, Government introduced One Time Settlement (OTS) Scheme for payment of penalty of Seigniorage fee on the consumption of Minor Minerals in construction activity with the terms and conditions mentioned therein.
2. In partial modification of the One Time Settlement Scheme, Government hereby amend the items 2 & 3 under terms and conditions of the above said G.O. as follows:
 - (2) The constructions shall be classified into two categories viz., (i) small commercial constructions (less than 5000 sft of built up area); and (ii) large commercial, apartments and commercial residential complexes. The approved building plans by the appropriate local body shall be relied upon to determine the category.
 - (3) Under the OTS, Category (i) shall pay normal Seigniorage Fee; Category (ii) shall pay one time penalty on the original assessment.
3. The other terms and conditions mentioned in para-8 of One Time Settlement Scheme as ordered in G.O. read above shall remain unchanged.
4. This order issued with the concurrence of Finance Department vide their U.O.No.354/37/EBS-VII/I&C//2015, dated: 07.02.2015.
5. The Director of Mines and Geology, Hyderabad shall take further necessary action in the matter accordingly.
