ORDER:

The differential global positioning system is an enhancement to the global positioning system that provides improved location accuracy. It uses a network of fixed, ground-based reference stations to broadcast the difference between the positions indicated by the global positioning system satellite and the known fixed positions.

2. In the reference second read above, the Ministry of Mines, Government of India issued certain amendments to the Mineral Concession Rules, 1960 including Rule 33 on the 'survey of the area leased' on the survey and demarcation of the area granted under lease and the survey of the area leased is to be conducted by the total station and differential global positioning system.

3. In the reference third read above, the Ministry of Mines, Government of India notified the Mineral (Auction) Rules, 2015 for allotment of mineral blocks through auction. As per Rule 5 and 9 of Mineral (Auction) Rules, 2015, the State Government shall, prior to issuance of the notice inviting tender with respect to mineral auction, identify and demarcate the area where a mining lease is proposed to be granted through auction by using total station and differential positioning system.

4. Similar procedure has to be adopted for grant of prospecting license/quarry leases in respect of minor minerals also for accuracy of the area under license/lease.

5. In the reference fourth read above, the Director of Mines & Geology submitted proposals for issue of Expression of Interest notification inviting applications for empanelment of agencies for use of differential global positioning system-total station survey for geo-referencing of the boundaries of the area(s) held under prospecting license/mining lease and quarry lease and for demarcation of mineral blocks for allotment.

6. Accordingly, the following notification shall be published in an Extra-ordinary Issue of Telangana Gezette dated the 22nd March, 2016.

NOTIFICATION

In exercise of the powers conferred by Section 15(1) of Mines and Minerals (Development and Regulation) Act, 1957 (Central Act 67 of 1957) the Governor of Telangana hereby issues the following order:

[P.T.O]

1. The Government shall issue Expression of Interest notification inviting sealed applications on attached format from organization/agency/individuals for Empanelment of Agencies for DGPS-Total Station Survey and Demarcation of the existing prospecting license/mining lease and quarry lease and for demarcation of mineral blocks for allotment duly fixing a suitable date for opening and closure of the Expression of Interest.
2. The Expression of Interest shall consist of applicants profile, financial details, experience of the applicant in survey and demarcation work with DGPS and Total Station, Technical Resources of the applicant, scope of work alongwith general terms and conditions as per formats annexed to these orders.
3. The Director of Mines & Geology shall be:
 - i. The receiving and processing authority on the applications received under the Expression of Interest.
 - ii. After verification of the documents shall submit proposals to the Government with specific recommendations against each application.
4. The Government shall issue notification empanelling the agencies.

ANNEXURE-IV

OBJECTIVE OF EMPANELMENT

(A) Scope of Work

1. Empanelment of Agencies for DGPS-Total Station Survey and Demarcation in the State of Telangana for the existing mining lease/prospecting license/quarry lease/applied area and Mineral Blocks in the State of Telangana as per Rule 33 of Mineral Concession Rules, 1960 and Rule 5 and 9 of Mineral (Auction) Rules, 2015.
2. Acquisition of certified copies Khata/Khasra and Village Maps will be responsibilities of Tenderer.
3. Acquisition of GTS Points and RL from Survey of India will be the sole responsibility of the Tenderer.
4. Acquisition of Satellite Imageries will be the sole responsibility of the Tenderer.
5. The Survey Agency shall be responsible for the accuracy of the data collected during Survey.
6. Co-ordinates of the Boundary Pillars shall be established in the world Geodetic System, 1984 (WGS-84) datum.
7. Reports of this work have to be submitted in hard as well soft copy in desired format of Directorate of Geology.
8. The time limit of completion of work will be 2 months from the date work order.
9. Firstly draft copy of the report should be submitted to Directorate of Geology then after the approval of the Draft copy final report should be submitted in four copies with all text, maps, all enclosures and calculation sheet.
10. The copy right of this report will be solely of Directorate of Geology. No part of the report can be used in any format without proper & prior permission of the Directorate of Geology.
11. Tenderer will have to fix RCC Permanent boundary pillars on ground after completion of DGPS-Total Station Survey and Demarcation in following manner:-
 - i. Each Boundary Pillar shall be surveyed using DGPS atleast 2 hour observation for its ground position.
 - ii. The minimum distance between two successive pillars should not be more than 50 meters.
 - iii. The Pillar shall be square pyramid frustum shaped above the surface and cuboid shaped below the surface. Each pillar shall be of Reinforced Cement Concrete (RCC). The corner pillar shall have a base of 0.30mX0.30m and height of 1.30m of which 0.70m shall be above ground level 0.60m below the ground.
 - iv. The intermediate pillars shall have a base of 0.25mX0.25m and height of 1.00m of which 0.70m shall be above the ground level and 0.30m below the ground level.
 - v. All the pillars shall be painted in yellow colour and the top ten centimeters in red colour by enamel paint and shall be grouted with the cement concrete.
 - vi. The tip of all the corner boundary pillars shall be a square of 15 centimeter on which a permanent circle of 10 centimeter diameter shall be drawn by point or engraved and the actual boundary points shall be intersection of two diameters drawn at 90^o.
 - vii. Distance and bearing to the forward and backward pillars and latitudes and longitude shall be marked on the pillars.

(B) Responsibility of the Selected Applicant:

- i. The project work will be under the supervision and control of Director of Mines & Geology, Telangana.
- ii. The selected firm/firms will identify and nominate the representative (s) of their respective organization in carrying out the project successfully who will act as the project Leader from the firm's side.
- iii. The firm/firms shall be responsible for any modification and the related costs if the output product does not (a) comply with the specification as per its proposal or (b) rejected by Director of Mines & Geology, Telangana. Such modification work shall not exceed three weeks from the date of notification and shall adhere to the time schedule specified in the award or as may be mutually agreed upon.
- iv. The firm/firms shall not reveal give or sale the output/project information to any other party except than DMG, Telangana. The cost of such modification/modifications will be born by the firm/firms.
- v. The firm/firms shall make available softcopies of all output/data base to Director of Mines & Geology, Telangana.
- vi. The firm shall/may be required to do all such things as shall be necessary to supply all the technical data and information and technical assistance in respect of the project before its implementation at the request of Director of Mines & Geology, Telangana.

(C) Proprietary Rights:

- i. The survey output will be proprietary rights of Director of Mines & Geology, Telangana.
- ii. The firm/firms will keep the documents which contain or related to the development results for reference until such documents are delivered to Director of Mines & Geology, Telangana and shall promptly provide Director of Mines & Geology, Telangana with replacements thereof in case of loss or damage thereto. The firm/firms assume(s) liability for damages which are caused by the service/project before the same are handed over to Director of Mines & Geology, Telangana.
- iii. Director of Mines & Geology, Telangana represents and warrants that it has sufficient power, right and authority to enter into agreement and undertake the obligations set forth in the agreement.

(D) Technology Transfer

The firm/firms shall transfer the technology from the very beginning of starting of work till completion.

GENERAL TERM & CONDITION

- ❖ Applicant will be requested to give presentation of their work, procedure and experiences of performing DGPS-Total Station Survey Demarcation of Mineral Block before Technical Committee on informed date.
- ❖ The date of Technical presentation will be informed later.
- ❖ Selected Applicant will be asked for submission of Financial Bid on the later stage.
- ❖ The empanelment will be valid for **three years** from the date of deposit of security money as mentioned below:

The selected firms will be required to deposit an amount of **Rs.50,000/- (Rupees fifty thousand only)** in the form of Bank Guarantee issued by any Nationalized bank in favour of **Director, Department of Mines & Geology, Government of Telangana, Hyderabad**. This will be an interest free refundable deposit. In case of deviation of agreed terms & conditions, the security deposit will be forfeited. In case the firm/firms want(s) to withdraw themselves from the Empanelment list, the security deposit may be refunded to the firm/firms after deducting receivables of DMG, Telangana if any. Security deposit shall be refunded on expiry of validity period unless renewed by DMG, Telangana. In case work order is issued and the firm/Agency does not complete the work, the Security deposit shall be forfeited, provided situation on work site is proved to be beyond the control of the agency/firm and same is acceptable by the competent authority then this condition shall be waived.

Director of Mines & Geology, Telangana will evolve a rate contract through invitation of offers from empanelled vendors. Work shall be distributed to vendors/among vendors depending upon their capabilities and urgency of the Department. The decision of Director of Mines & Geology, Telangana in this regard shall be final. However, for execution of any complex project, Director of Mines & Geology, Telangana will select and invite firms from the empanelment list based on their suitability and capability matching the scope of the same project to participate in the tender for the project. The techno-commercial bids of the selected empanelled firms will be evaluated by the technical as well purchase committee of Director of Mines & Geology, Telangana. The L1 price offered by the firms through tender process shall be allotted the work to be executed. Director of Mines & Geology, Telangana, reserves the right to execute the job-work through any other firm/firms of its choice.
