**ORDER:**

As per Section 93 of the A.P. Reorganization Act 2014 read with Schedule 13<sup>th</sup> of the Act under Infrastructure development, the Central Government shall take all necessary measures for establishment of an integrated steel plant in Khammam, Telangana State by Steel Authority of India Limited (SAIL).

2. In the reference 2<sup>nd</sup> read above, the Director of Mines & Geology, Hyderabad has stated that a team of Steel Authority of India Limited officials visited Khammam in May, 2014 for short listing area for establishment of steel plant. Further, Steel Authority of India Limited have requested the State Government for furnishing the details on availability of 200 Million Tons of specified grade Iron Ore in addition to other raw materials, subsidies and concessions. As per preliminary reports from Geological Survey of India, about 302 million tons of various grades of Iron Ore is available in the State. However, it needs a systematic resource evaluation about suitability for Steel Authority of India Limited requirement of 200 MT of Iron Ore.

3. The Director of Mines & Geology, Hyderabad further stated that a Task Force has been constituted at Ministry of Steel, New Delhi to review the establishment of Steel Plant at Khammam. In the Task Force meetings, Steel Authority of India Limited requested the State Government to come up with specific details on the availability of Iron ore. In this regard, the Government held a review meeting with Geological Survey of India, Indian Bureau of Mines, Mineral Exploration Corporation Limited, Singareni Collieries Company Limited, M/s Telangana State Mineral Development Corporation Limited and Department of Mines & Geology. After detail discussions, it was decided that the Geological Survey of India shall arrange the details on the availability of Iron Ore blocks and M/s Telangana State Mineral Development Corporation Limited shall prepare a road map for systematic resource evaluation.

4. The Director of Mines & Geology, Hyderabad therefore recommended the Government for declaration of M/s Telangana State Mineral Development Corporation Limited (TSMDC) as Nodal Agency and also to take up exploration by calling private exploration agencies for all Iron Ore blocks falling in Adilabad, Karimnagar, Warangal, Khammam and Nizamabad Districts, since these blocks are being reserved for M/s Telangana State Mineral Development Corporation Limited for exploration and exploitation.

5. Government, after careful consideration of the matter, hereby notify M/s Telangana State Mineral Development Corporation Limited as Nodal Agency for Iron Ore blocks to take up exploration by calling private exploration agencies, since all Iron Ore blocks are being reserved for M/s Telangana State Mineral Development Corporation Limited for exploration and exploitation duly evolving and following a transparent procedures in this regard.
