(vii)	Lead Bank Officer of district, nominated by the Governing Council.	:	Member
(viii)	District Social Welfare Officer concerned.	:	Member
(ix)	District Medical & Health Officer.	:	Member
(x)	District Educational Officer.	:	Member
(xi)	Executive Engineer, Rural Water Supply.	:	Member
