M/s.Telangana State Mineral Development Corporation Limited shall claim operational expenses of Corporation and Direct expenses incurred for sale of sand like Seigniorage Fee, Sand Raising Cost, Stockyard maintenance Cost, Financial Expenses, Associated Licenses/Permits Expenses/Cost, Village Development Fund Fee, District Mineral Trust Fund Fee and support charges @ 6% on sand sale proceeds on monthly basis from Government duly following all norms of financial prudence.

The Vice-Chairman & Managing Director, Telangana State Mineral 3. Development Corporation Limited shall take further necessary action in the matter accordingly.
