Mines and Minerals - Telangana Minor Mineral Concession Rules, 1966 - Procedure for Grant of Minor Mineral Concessions in Pattalands other than by auction - Notification -Orders - Issued

O R D E R:

In the G.O. second read above, the Government made certain amendments to the Telangana Minor Mineral Concession Rules, 1966 issued in the G.O. first read above, to grant quarry leases for Minor Minerals except ordinary sand and areas reserved under Rule 9-A through auction. As per the said rules, the procedure for grant of Minor Mineral Concessions in Pattalands shall be prescribed by the State Government.

2. The Director of Mines and Geology, Hyderabad, in the letter third read above has submitted proposals to grant Minor Mineral Concessions in Patta lands, where the pattadars have not given consent for auction; by collecting a non-refundable amount equivalent to 5-times of Dead Rent for granite and marble and ten times of Dead Rent for 31 minerals and other minor minerals from the pattadars while granting the leases in order to maintain parity with leases granted through auction. The pattadars shall submit an application before the Assistant Director of Mines and Geology concerned for grant of lease and all necessary statutory clearances shall be obtained by the pattadars. The quarry lease granted to pattadars shall be subjected to the Telangana Minor Mineral Concession Rules, 1966.

3. Government after careful examination of the matter hereby approves the proposal of the Director of Mines and Geology, Hyderabad and decided to prescribe the procedure for grant of Minor Mineral Concession in Patta lands, where the pattadars have not given consent for auction.

4. Accordingly, the following Notification shall be published in the Telangana Gazette, dated:10.11.2022:

NOTIFICATION

In exercise of the powers conferred under rule 12 of the Telangana Minor Mineral Concession Rules, 1966 issued in G.O.Ms.No.1172, Industries (B-1) Department, dated 04.09.1967 as amended subsequently from time to time, the Government hereby prescribe the following procedure for grant of Minor Mineral Concessions in Pattalands, where the Pattadar has not given consent for auction:

The Pattadar shall submit an application to the Assistant Director of Mines and Geology concerned for grant of Minor Mineral Concessions and shall pay a non refundable amount equivalent to 5-times of Dead Rent for Granite and Marble and 10 Times of Dead Rent for 31 Minerals and other Minor Minerals. The statutory clearances shall be obtained by the Pattadar.
